#### **REVIEW APPLICATIONS FOR IMPROVEMENT:**

### 10575 Livewood Way

An Application to document the previously completed replacement of backyard trees was reviewed and **Approved.** 

#### 10574 Livewood Way

An Application to install El Dorado Cypress Ridge Orchard decorative stone veneer over the existing external brick chimneys was reviewed and **Approved.** 

#### 10415 Spruce Grove Avenue

An Application to repaint the home's exterior was reviewed and **Approved.** Front facing wood siding will be Behr MS20-7 "Admiral" Blue". Trim, facia, doors etc. will be repainted white, with gray window frame accents as at present.

## 12296 Semillon Blvd

An Application to install a backyard solar array could not be reviewed, because the owner has not provided the requested clarifying information.

# **10262 Pinecastle Street**

An Application to install a 12' x 14' stand-alone wooden pergola over the backyard patio was reviewed and **Approved**.

#### 10354 Barrywood Way

An Application to install 2 Velux fixed skylights (22"x46"), in the lower, front facing roof was reviewed and **Approved with Conditions** visible skylight trim must be a dark finish compatible with the dark colored roof.

#### 10343 Pinecastle Street

An Application to replace the existing grass with Coronado 80 artificial turf, remove the existing concrete spa area and replace it with a planting area was reviewed and **Approved**.

#### 12369 Kingspine Avenue

An Application to repaint the home's existing gray siding and fences with Dunn Edwards "Edge of Black" was discussed. However, no decision can be reached until the homeowner provides the requested clarification and large scale sample of the paint color in place: address of an existing house, or trial application of "Edge of Black" to their home's front facing wooden fence.

#### **10525 Spruce Grove Avenue**

An Application to install rooftop photoelectric panels and associated equipment was reviewed and **Approved**, with the standard WRHOA solar requirements.

#### 10318 Walnutdale Avenue

Diagrams and support materials for the relocation of existing solar water heating panels and installation of a rooftop solar-electric system were reviewed and discussed. The Committee is prepared to approve the project, with standard WRHOA solar conditions, when a properly executed Application for Improvement is submitted.

## 12496 Kingspine Avenue

An Application to install three Magnolia trees along the north facing sideyard fence was reviewed and **Approved**

#### 12433 Grainwood Way

An Application has been submitted for replanting of the property's rear slope without neighbor awareness signatures from those Kingspine homes with direct view of the area. Final plans for replanting trees and ground cover are expected soon.
