The Committee Burr mentioned that he hadn't heard from the owner after requesting he submit an artificial turf sample that is greener. Burr mentioned that he will send him a follow-up email regarding his project.

12433 Grainwood Way

The Owner has submitted a plan to recover the trees that were cut. Committee member Tysdal mentioned that the eucalyptus drawing was not specific. Burr mentioned that the area looks a little naked at the bottom of the slope. Tysdal reminded the committee that the owner had concerns with fire safety and that the owner should follow the City of San Diego Cal Fire regulations. Tysdal will send Burr the links for what Cal Fire says for different situations.

The Committee reviewed the features for the Smartwebs platform. Wenhardt mentioned that he still does not have access. Management will follow-up with the IT Dept to add the correct email.
