REVIEW APPLICATIONS FOR IMPROVEMENT:

12885 Meadowdale Ln.

CALL TO ORDER:

Homeowners wish to complete a fence replacement.

The committee approved the project on September 21st, 2022, with the following conditions: Open Wrought iron fence and gate on left side of the house must be same height as existing adjacent fence and backed with perforated metal or screening to provide effective visual barrier for trash cans and equipment. Screening is not mandatory on right side fence because of limited visibility but may be used at homeowner's discretion. Color should be standard wrought iron black or painted to match the house and adjacent fencing.

<u>10350 Walnutdale St.</u> Homeowners wish to complete a fence replacement.

The committee approved the project on September 21st, 2022, with the following conditions: Gap of 10mm should be small enough to hide trash cans.

<u>12454 Oakfort Pl.</u> Homeowners wish to complete a landscape project in the backyard.

The two attendees requested clarification on who the two signatures on the application belong to. Signatures from the adjacent neighbors and the two neighbors across the street should be requested.

10607 Birch Bluff Ave.

Homeowners wish to repaint the garage door and front door to match the current shutters and change the white railing on the back of the house black to match the rest of the gates and railings.

The two attendees requested a sample of the current color of the shutters.

12312 Kingspine Ave.

Homeowner provided requested clarifying information and detailed renderings for a landscape project in the backyard.

The two attendees recommended the project be approved and requested a digital copy of the rendering showing the retaining walls, drainage, irrigation system. The front landscape application was reviewed and approved by the full Committee on July 19th, 2022.
