ACTION ITEMS: Treebeard Increase

Upon a motion duly made, seconded and carried unanimously, the Board approved a rate increase from Treebeard from \$8,439.00 to \$8,839.00, effective January 1, 2022. (Spitzberg/Bernardo)

Annual Tree Trimming Proposal

Upon a motion duly made, seconded and carried unanimously, the Board approved the proposal from Atlas Tree for the Association's annual tree trimming in the amount of \$16,555.00, which falls in line with the Association's budgeted rate and previous costs. (Bernardo/Kenis)

Protec Proposal

Upon a motion duly made, seconded and carried unanimously, the Boad approved the recommendation from ProTec Plumbing to re-route the venting on the tankless water heater located by the pool showers to alleviate the smell of gas from occurring at a cost not to exceed \$1,065.00. (Spitzberg/Kenis)

Fire Pits

The Board discussed options to install fire pits at the pool area. Board members will continue to explore options and placement, to be revisited when narrowed down. No action at this time.
